**ORDER**

As per the Tree Transplantation Policy, 2020 approved by State Cabinet vide Cabinet Decision No. 2876 dated 09.10.2020, as a general rule, it shall be mandatory for all developmental projects to ensure that a minimum 80% of the affected trees are scientifically transplanted. Para 7 of the policy requires that the Department of Forests and Wildlife shall empanel qualified transplantation agencies that meet minimum technical criteria and expertise to carry out transplantation work in Delhi.


An Expert Committee was constituted to decide the minimum technical eligibility criteria for empanelment of agencies after getting approval of the Hon'ble Minister (E&F), Govt. of NCT of Delhi.

After deciding the minimum eligibility criteria a public notice was issued in newspapers for receiving Expression of Interest (EOI) from agencies regarding Tree Transplantation in Delhi. After scrutiny of technical bids by the Expert Committee and obtaining approval of the competent authority the following agencies are being technically empanelled to carry out the work of tree transplantation in the NCT of Delhi:

- a) Green Morning Horticulture Pvt. Ltd, Plot No. 634, H.No. 8-1-284/634, First Floor, Above Andhra Bank ATM, Near Dream Valley, OU Colony, Manikonda, Hyderabad, Telangana-500008.
- b) M/s Rohit Nursery, E-70, Shyama Prasad Mukherjee Enclave, Palam-Dabri Road, New Delhi-110045.
- c) M/s DD MEP Engineers, E-2116A Palam Vihar, Gurgaon, Haryana-122001.
- d) RP Entrepreneur, B-1780, Shastri Nagar, Delhi-110052

To carry out tree transplantation from any project site in the National Capital Territory of Delhi, the project developer shall be required to select an agency from among the empanelled agencies only. The empanelled agency shall adhere to all the technical specifications for carrying out tree transplantation in Delhi as issued from time to time by the Department.
